ORDER

Mr. S. S. / 102/102/2003 / Special class

is hereby appointed as A.T.A. on contract basis at Rs. 7200/- (Rupees seven thousand two hundred) only with effect from the date of joining in the concerned school for a period of one year against Centrally sponsored Govt. of Arunachal Pradesh. He/she is posted to Govt. Kamang Middle School, Abhiyan under the disposal of Distt. Pongma District.

He is directed to report immediately to the DIET Pongma for 30 days pre-service induction training which will be effect from 16/05/03 before joining into posting place will be accepted only after completion of induction training.

The appointment is subject to the following

Conditions :-

- a) The contract appointee has no right to claim for regular appointment/re-appointment if the post after expiry of contract appointment.
- b) No earned leave is permissible except casual leave as per COS leave rule and as per the terms and conditions mentioned in the agreement form.
- c) During contract service period he/she is not entitled for medical re-imbursment/winter allowances/children education allowance/re-imbursment of tuition fees/leave travel concession (LTC)/Special compensatory allowance.
- d) The Contract appointee have to report his/her duty at posting place within 7(seven) days from the date of completion of induction training failing which his/her appointment will automatically be treated as cancelled.
- e) He/she is not entitled to subscribe to G.P.F. or C.G.E.I.S or such other schemes during the period of contract service.
- f) The other terms and conditions of the service which are not specified here shall be governed by relevant rules and orders in force from time to time, and the terms and conditions mentioned in agreement signed by him/her.
- g) The appointed teacher is also to work as Volunteer Instructor for IC programme for the interest of literacy in Arunachal Pradesh in addition to his normal duties.
