is hereby appointed provisionally to officiate as Asst. Teacher Grade-'A' under the Education Department, Govt. of Arunachal Pradesh and posted to Dupu Fry School under W. S. Circle in the scale of pay of Rs 1200-30-1550-EB-40-2040/- per month plus other allowances as admissible under rules from time to time w.e.f. the date of his/her joining at the posting place.

2. The appointment is subject to the following conditions:-

a. The appointment is purely on probation for a period of 2 (two) years and may be terminated at any time without assigning any reason after giving one month's notice from either side.

b. After joining duty he/she will have to take oath of allegiance or give affirmation to the Constitution of India duly in the prescribed form.

c. He/she will have to produce a Medical Certificate from an authorised Medical Officer to the effect that he/she is medically fit for the Govt. Service.

3. The appointment is subject to the Police Verification and he/she will be discharged from service with immediate effect if there will be any adverse remarks against him/her in the Police report.

4. The teacher must join his/her duty at his/her place of posting within 30 (thirty) days from the date of receipt of this order.

5. The terms and conditions which are not specified here would be governed by the rules and orders in vogue in force from time to time.
