- b) During contract service period, he/she is not entitled for reimbursement, winter allowances, children educational allowance, reimbursement of tuition fees, leave travel concession, special compensatory allowances and any other such allowances.
- c) The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the concerned DISE/Office failing which his/her engagement order will automatically be treated as cancelled.
- d) He/she is not entitled to availed any leave by such contract schemes during the period of contract services.
- e) The engaged teacher is also to work as volunteer instructor of TLC/PLP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the state Govt./Dist. Administration/ Education Department in any addition to his/her normal duties.
- f) No representation will be accepted for change of posting place.
- g) He/She will have to under gone DIET for training as and when called for.
- h) The other terms and conditions of services which are not specified shall be governed by the Relevant rules/Orders/Guide lines/Instructions in force time to time.
- i) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- j) His/Her contractual service will remain valid only up to 31/3/08 and thereafter it will be treated automatically terminated. Fresh renewal would be required.
- k) He/She will have to report for duty at his/her posting place positively on 17/3/07. His/her pay will be drawn only after getting joining report through the concerned APO(AD)/ADCO.
- l) The Second Party Shall be entitled for drawal salary of only the academic session. Salaries for vacation period shall be drawn only when they are engaged in training. Bridge course and any other departmental engagement.
