ORDER

✓ Shri/Smti Tana Joni is hereby engaged as A/T on contract basis in the fixed pay of Rs. 7200/- (Rupees Seven thousand two hundred) only with effect from the date of joining in the concerned school up to 31/03/2009 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He/She is posted at Primary/Upper Primary School/ Residential School, Kheel (Toru)

The engagement is made vice resignation/expire/waiting panel/not joined of Shri/Smti/Miss JT/AT (SSA) (Application in case of resultant vacancies).

The engagement is subject to the following conditions: -

- a) The contract Teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.
- d) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned DPO failing which his/her engagement order will automatically be treated as cancelled.
- e) He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract services.
- f) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/She will have to undergo DIET training at concerned DIET for training as and when call for.
- i) The validity of contract period is upto 31/03/09, which may be extended by seeing the performance/regularity of teacher as recommended by concern VEC.
- j) The other terms and conditions of Service which are not specified shall be governed by the relevant rules and order in forced time to time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
