During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel c) concession (LTC); Special compensatory allowance etc.

The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned Administrative Officer, failing which his/her d) engagement order will automatically be treated as cancelled.
