  - c) After joining duty she will have to take an oath of allegiance of affirmation to the constitution of India in the prescribed form.
  - d) He/She will have to produce Medical fitness Certificate from an authorized Medical Officer.
  - e) The appointment is subject to the Police Verification and she will be dismissed from Govt. service if any adverse report is there with immediate effect.
  - f) The other terms and conditions of service which are not specified herein, shall be governed by the relevant rules and order's in force form time to time.
