a) The contract Teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.

b) No Enrued leave is permissible except casual leave as per Central Civil Service Leave Rule

and as per terms and conditions mentioned in the agreement copy.

c) During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concessión (LTC); Special compensatory allewance etc.

d) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned SDO/EAC/CO, failing which his/her engagement order will automatically be treated as cancelled.

e) He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract services.

The engaged teacher is also to work as volunteer instructor for TLC-programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.

No representation will be accepted for change of posting place.

h) He/She will have to undergo DIET training at concerned DIET for training as and when call
