is hereby appointed as J/T on contract basis in the fixed pay of Rs. 8500/- (Rupees eight thousand five hundred) only with effect from the date of joining in the concerned school for a period of one year against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He/she is posted to Govt. Along I.T. School,

under the disposal of DDSE, Tawang District Tawang

He/she is directed to report immediately to the DDSE Tawang for duty.

He/she will have to undergo a 30 days induction training with effect from 15/3/2023 at DIET Tawang. His/her continuation in the contract service will be subject to the condition that he/she completes the 1(one) months induction training and after completion of his/her training he/she join as back to the school as per posting place above.

The appointment is subject to the following conditions :-

- a) The contract appointee has no right to claim for regular appointment/regularization of post after expiry of contract appointment.
- b) No Earned leave is permissible except casual leave as per CCS leave rule and as per terms and conditions mentioned in the agreement form.
- c) During contract service period he/she is not entitled for medical re-imbursement/Winter allowance/Children education allowance/re-imbursement of tuition fees/leave travel concession (LTC)/Special compensatory allowance.
- d) The contract appointee have to report his/her duty at posting place within 7(seven) days of issue of the appointment order and also within 7(seven) days from the date of completion of induction training failing which his/her appointment will automatically be treated as cancelled.
- e) He/she is not entitled to subscribe to GPF or CCEIS or such other schemes during the period of contract service.
- f) No TA/DA will be granted to him for journey period for reporting to the training center from his/her place of posting and back to his/her posting place after the completion of training.
- g) The other terms and conditions of the service which are not specified herein shall be governed by relevant rules and orders in force from time to time, and the terms and conditions mentioned in agreement signed by him.
- h) The appointed teacher is also to work as Volunteer Instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his normal duties.
