Shri/Smt Dorjee Khuisney is hereby appointed to officiate as PTI in scale of pay of Rs. 10,000/- P.M. plus other allowances as admissible under rules from time to time with effect from date he/she actually reports for duty to Principal Govt. H. Sec. School, Kalaklang, W/Khony Distt. (A.P)

2. The appointment is made against the vacancy post of PTI.
3. The officer shall be on probation for a period of two years with effect from the date of joining. He/she shall be in service beyond probation period of two years only if he/she shows satisfactory performance during probation period.

4. The appointment is subject to the following conditions:-

- a) The appointment is purely temporary and may be terminated at any time without assigning any reasons. If he/she wants to resign he/she may do so after giving one month's notice and by surrendering one month pay.
- b) After joining the duty he/she shall have to take on oath of allegiance of affirmation to the constitution of India in the prescribed form.
- c) He/She will have to produce Medical Fitness Certificate in prescribed form from an authorized Medical Officer.
- d) The appointment is subject to Police Verification and he/she will be dismissed from Govt. Service if any adverse reports are there with immediate effect.
- e) The other terms and condition of services which are not specified herein, shall be governed by the relevant rules and orders in force from time to time.

5. Shri/Smt Dorjee Khuisney shall have to continue for a minimum tenure of 3 (three) years terms in his/her present posting place.
