ORDER

Miss Naham Mery, is hereby engaged as A.T on compactual basis against the PAI sanction of 2010-11 under Papumpare district in the fixed pay of Rs. 7200/- (Rupees Seven Thousand Two Hundred only with effect from the date of joining in the concerned district against centrally sponsored scheme of Sarva Shiksha Abhiyan. She is posted to Govt. UPS. Rono of District Papumpare.

The engagement is subject to the following conditions:-

- a. The contract teacher has no right to claim for regular appointment/ regularization of the post after expiry o contract engagement.
- b. No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as peterms and condition mentioned in the agreement copy.
- c. During contract service period he/ she is not entitle for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC): Special compensator; allowances etc.
- d. The Second party shall be entitled for drawnl salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training. Bridge course and any other departmental engagement.
- e. He/ she is not entitled to subscribed GPF or CGEIS or such other schemes during the period of contrac services.
- I. The engaged teacher is also to work as volunteer instructor for FLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- g. No representation will be accepted for change of posting place.
- h. He she will have to under gone DIET training at concern DIET for Training as and when call for.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- i. The engaged teacher has to sign an agreement for contract engagement before receiving this engagemen order.
