**ORDER**

Miss Kipa Lungbey is hereby engaged as A/T on contract basis in the fixed pay of Rs. 7200/- (Rupees Seven Thousands Two Hundreds) only against Centrally Sponsored Scheme of SARVA SHIKSHA ABHIYAN. She is posted at Govt. Primary School, 5/1 Banderdewa under Banderdewa Circle.

The engagement is subject to the following conditions: -

- a) The Contract Teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
- c) During contract service period she is not entitled for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.
- d) The contract teacher have to report her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned CO, failing which her engagement order will automatically be treated as cancelled.
- e) She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract service.
- f) The engaged teacher is also to work as volunteer instructor for TLC Programme for the interest of the literacy in Arunachal Pradesh in addition her normal duties.
- g) No representation will be accepted for change of posting place.
- h) She will have under go DIET training at concerned DIET for training as and when call for.
- i) The validity of contract periods is up to 31/3/2008, which may be extended by seeing the performance/ regularity of teacher as recommended by the concern V.E.C.
- j) The other terms and conditions of service which are not specified shall be governed by the relevant rules and other in forced time to time.
