- 3. The promotee carries with the liabilities to serve in any Govt. Secondary/ Higher Secondary School of Arunachal Pradesh.

- 6. No representation regarding change of place of posting will be entertained in any circumstances.
- 7. The other terms and conditions which are not specified herein shall be governed as per existing Government Rules and Orders in force from time to time.
