O R D E R

On the basis of Walk-in-Interview held on 5<sup>th</sup> October'2021, Mrs. **Nichi Mary Charu** is hereby engaged as **Primary Teacher** on contract basis in the fixed pay of **Rs. 15,000/- (Rupees Fifteen Thousand) only** for current academic session, upto 31<sup>st</sup> March'2022 with effect from the date of joining in the district against Centrally Sponsored Scheme of ISSE/Samagra Shiksha. She is posted at Govt. Residential School, **Dokio Langpo** under **Palin** Circle.

The engagement is subject to the following conditions: -

1. The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of issue of Appointment order in the concerned school, failing which his/her engagement order will automatically be treated as cancelled.
2. The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
3. The Contract Teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
4. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and condition mentioned in the agreement copy.
5. If the incumbent remain absent, no Pay will be paid for the absent periods.
6. In case, the appointee is found not staying in his /her place of posting and not sincere in his/her duty, his/her Contract Service will be terminated at any time by the ISSE/Samagra Shiksha District Society.
7. At the end of the contract Agreement, the incumbent shall have to again enter into fresh contract for the next academic period.
8. During contract service period he/she is not entitle for Medical Reimbursement, Winter Allowance, Children Educational Allowance, Reimbursement of Tuition Fees, Leave Travel Concession (LTC), Special Compensatory Allowance etc.
9. The Second Party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge Course and any other departmental engagement.
