**ORDER**

In pursuance of the Govt. Approval vide U.O.No. 901 (B) dated 30/12/2015, Miss Dinash Taki is hereby appointed temporarily as Trained Graduate Teacher (Social Studies) in the pay scale of PB-2-9300-34800 + GP-4600/- per month plus other allowances as admissible under rules from time to time with effect of the date he/she actually reports for duty at Govt. Higher Secondary School, Pangin under DDSE, Pangin, Siang District

The appointment is made against the resultant vacancy of Sri Sant Kumar Dewan, TGT, retired.

The appointment shall be on probation for a period of 2 (two) years w.e.f the date of joining. His/her continuation beyond probation period for 2 (two) years shall be subject to satisfactorily performance during probation period.

**The appointment is made subject to the following conditions :-**

1. *The appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice. If he/she want to resign, he/she may do so after giving one month notice or by surrendering one month salary.*
2. *The confirmation of service will be considered on completion of probationary period subject to satisfactory performance of duty.*
3. *After joining duty he/she will have to produce Medical Fitness Certificate issued by Govt. recognized Medical Board.*
4. *The appointment is subject to Police Verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.*
5. *After joining duty he/she will have to take oath an allegiance of affirmation to the Constitution of India in the prescribed form.*
6. *On joining, the appointee shall have to serve for a minimum period of 05 (five) years at the place of posting.*
7. *The seniority of the appointee shall be based strictly on merit list.*
8. *The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 30 (thirty) days from the date of issue of this order at posting place.*

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
