ORDER

In pursuance of Govt. approval vide U.O.No. 87 Dated 16/05/07. / Shri / Smti / Miss Taje Maying, B.Com is hereby appointed temporarily to officiate as AT (A) on compassionate ground in the scale of pay of Rs. 4500-125-7000/- PM plus other allowances as admissible under rule from time to time with effect from the date she / he actually reports for duty to the DDSE, Daporijo. She / he is posted at Govt. Sec. School, Ligu, Upper Subansiri District, Arunachal Pradesh.

2. The appointment is made on compassionate ground as per Govt. of India Ministry of Home Affairs order No. 14014/20/90 Estt. (D) Dated 9/12/93. She / he is appointed against Miss / Smti / Shri T. Goswami, AT (A) Retired.

Appointment is subject to the following conditions: -

- a) The appointee shall be on probation for a period of two years w.e.f. date of joining. His / her continuation in the service beyond probation period of two years is subject to satisfactory performance of duty during probationary period.
- b) The appointment is purely temporary and may be terminated at anytime without assigning any reasons thereof. If he / she wants to resign he / she may do so after giving one month notice or by surrendering one month pay.
- c) After joining duty he / she will have to take an oath of allegiance of affirmation to the constitution of India in the prescribed form.
- d) She / he will have to produce Medical fitness Certificate from an authorized Medical Officer at the time of joining.
- e) The appointment is subject to the Police Verification and he / she will be dismissed from Govt. Service if any adverse report is there with immediate effect.

Other terms and conditions of service, which are not specified herein, shall be governed by the relevant rules and order in force from time to time.
