The engagement is subject to the following conditions: -

The Contract Teacher has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.

No earned leave is permissible except casual leave as per Central Civil Service Leave Rule and b) as per terms and conditions mentioned in the agreement copy.

During contract service period he is not entitled for medical reimbursement; winter () allowances; children educational allowance; reimbursement of tutton fees; leave travel concession (LTC); Special compensatory allowance etc.

The contract teacher have to report his duty at posting place within 7 (Seven) days from the d) date of joining in the office of the concerned ADC, failing which his engagement order will automatically be treated as cancelled.
