No. ED/2015/SE/290/APT/2015. It is hereby directed that a teacher is hereby appointed temporarily to the post of Trained Graduate Teacher (Matthew) as in the Schedule I of the Pay Matrix of Rs. 10,30,200/- GP/Rs. 4000/- PM and other allowances as admissible under rules in force. He / she will be required to report to the Director of Secondary Education on the 1<sup>st</sup> day of March, 2017 at the office of the Director of Secondary Education, Itanagar, Khasi Dadi District, Arunachal Pradesh.

The appointment is made w.e.f. 1<sup>st</sup> March, 2017, proceeded to PGT.

(i) The appointment is subject to the following conditions:-

- (i) The appointment is by contract basis for a period of two (2) years w.e.f. the date of joining and their services will be used on probationary basis.
- (ii) The appointment is purely temporary and may be terminated at any time by giving (one) month notice without assigning any reason thereof. If he / she wants to resign, he or she may do so after giving (one) month notice by tendering (one) month salary.
- (iii) The regularization of service shall be considered on completion of probationary period subject to satisfactory performance of duty in his/her initial place of posting.
- (iv) After joining duty, he / she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- (v) He / she will have to produce Medical fitness Certificate from an authorized Medical Officer.
- (vi) The appointment is subject to the Police Verification and he / she will be dismissed from government services if any adverse report is there with immediate effect.
- (vii) He / she shall remain in the office of posting for a minimum period of 3 (three) years from the date of joining. No re-appointment / continuation in the charge of posting place shall be entertained before completion of three years of service in the initial place of posting.

Other terms & conditions of service which are not specified herein shall be governed by the relevant rules and orders in force for the time being.
