**ORDER**

Miss Pania Yakar is hereby engaged as an **Assistant Teacher (A/T)** on contractual basis in the fixed pay of Rs.21,175/- (Rupees Twenty One Thousand One Hundred Seventy Five) only with effect from the date of joining in **Papum Pare District** under the centrally sponsored scheme of Sarva Shiksha Abhiya.

The engagement is subject to the following conditions: -

- The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- During contract service period he/she is not entitle for medical reimbursement; winter allowances; children educational allowance; reimbursement of tuition fee; leave travel concession (LTC); Special compensatory allowances etc.
- The Second party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any or
- The contract teacher have to report his/her duty at posing place within 7 (seven) days from the date of joining in the office of the concern DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- He/She is not entitled to subscribed GPF or CGEIS or such other scheme during the period of contract service.
- No representation will be accepted for change of posting place.
- He/She will have to under gone DIET training at concern DIET for Training as and when call for.
- The other terms and conditions of services which are not specified shall be governed by the relevant rules and order in forced time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.


