They will be on probation for a period of 02 (two) years with effect from the date of joining in their respective places of posting as shown above.

- The appointment is purely temporary and may be terminated without assigning any reason after serving one month notice. If he or she want to resign may require to give one month notice or surrender one month salary.
- After joining in the duty he or she shall take an oath of allegiance of affirmation in the constitution of India in the prescribed form.
- He or she will have to produce medical fitness certificate in the prescribed format from an authorized Medical Officer.
- The appointment is subject to Police verification and he or she be dismissed from Govt. service if any adverse report is there with immediate effect.
