The engagement is subject to the following conditions :-

- a) The contract teachers have no right to claim for regular appointment /regularization of the post after expiry of contract appointment.
- b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy
- c) During contract services period he/she is not entitle for medical reimbursement, winter allowances, children educational allowances, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowances etc
- d) The Second Party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course & remedial teaching and any other departmental engagement.
- e) The contract teachers have to report his /her duty at posting place within 5(five) days and submit joining report through respective school, failing which his/her engagement order will be automatically be treated as cancelled.

- f) He/she is not entitle to subscribed GPF or CPFIS or such other scheme during the period of contract services.
- g) The engaged teachers are also to work as volunteer instructor for TIC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- h) No representation will be accepted for changing of posting place.
- i) The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in force at time to time.
- j) The engaged teachers have to sign an agreement for contract engagement before receiving this engagement order
