No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditioned in the agreement copy.

During contract service period he/ she is not entitle for medical reimbursement; winter allowance; children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowances etc.

He she will have to under go DIET training at concern DIET for training as and when call.
