- d) He / she will have to produce Medical fitness Certificate from an authorized Medical Officer.
- e) The appointment is subject to the Police Verification and he/ she will be dismissed from Govt. service if there is any adverse report from the Police.
- f) On joining the appointee shall have to serve for a minimum of five years at the place of posting.
- g) The appointment order shall be cancelled, if the appointee directly or in-directly campaigns for change of place of posting or does not join within 10(ten) days from the date of issue of this order.

Other terms and conditions of service, which are not specified

herein shall be governed by the relevant rules and order in force from time to time.
