**ORDER**

In pursuance of Govt approval vide U.O. No. 104 dated 17.10.05 Mr. Kamaal Bala Suman is hereby appointed temporarily to officiate as Associate Lecturer (A) in the scale of pay of Rs. 4500-125-7000/- P.M. plus other allowances as admissible under rules from time to time w.e.f. he actually reports for duty at Govt. P.S. School, Dandamudi under the disposal of DDOE Sugga, District East Kamrup, Assam/Andhra Pradesh.

2 The appointment is made *vide* *Santhi Prati Sam* A1/Pranandhi.

3 The appointment shall be on probation for a period of three years w.e.f. the date of joining. Her continuation in service beyond probation period of three years is subject to satisfactory performance during probation period.

4 The appointment is subject to the following conditions -

- a) The appointment is purely temporary and may be terminated with three month notice. If she want to resign he may do so after giving three month notice as he applicable to her service rules.
- b) The continuation in service will be conditional on completion of probationary period subject to satisfactory performance of duty.
- c) After joining date she will have to take an oath of allegiance of allegiance to the Constitution in form as the prescribed form.
- d) She will have to produce Medical fitness Certificate from an authorized Medical Officer.
- e) The appointment is subject to the Police Verification and he will be discharged from Govt. serv. as if there is any adverse report from the Police.
- f) On joining the appointee shall have to serve for a minimum of five years in the place of posting.
- g) The appointment order shall be cancelled, if the appointee directly or indirectly campaigns for change of place of posting or does not join within 15 days from the date of issue of this order.

Other terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.

This supersede earlier orders issued

on 11/12/05.
