C) He/She will have to produce a MEDICAL CERTIFICATE from an authorised Medical Officer to the effect that he / she is medically fit for Govt. service.

D) The appointment is subject to the police verification and he / she will be dismissed from service with immediate effect if there be any adverse remarks against him/her in the police report.
