- c) He / she will have to produce Medical fitness certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police verification and she will be dismissed from service, if any adverse report is there with immediate effect.
- e) On their appointment as a Assistant Teacher (A) they should undergo compulsory in-service DPE/B.Ed. within 3 (three) years failing which their appointment order shall be cancelled.

The other terms and conditions which are not specified herein shall be governed by the relevant in force from time to time.
