## The Appointment is subject to the following conditions:-

- 1. The salary will be drawn from the date of his/her foining in the duty.
- 2. The Appointment is purely temporary and may be terminated at any time by giving 1(one) month notice. If he/she wants to resign, he/she may do so after giving one month notice or by surrendering one month salary.
- 3. The regularization of service will be considered on completion of probation period subject to satisfactory performance
- 4. After joining duty he/she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- 5. The appointment is subject to Police verification and he/she will be dismissed from service if any adverse report is found against him/her with immediate effect.

- On joining, the appointee shall have to serve for a minimum period of 3 (Three) years at the place of posting.

The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 15 (fifteen) days from the date of issue of this order at his/her posting place and copy of joining report be submitted to this Directorate through DDSE concerned.
