**ORDER**

**Shri/Smti/Miss Bini Ganga**, is do hereby appointed as Trained Graduate Teacher (TGT) on contract basis in the fixed pay of Rs, 20,000/- (Rupees Twenty Thousand) per month only, with immediate effect from the date of joining in the concerned school for a period of one year, against resultant vacancy of centrally sponsored scheme of ISSE/Samagra Shiksha. He/She is temporarily posted at **Govt. Secondary School Panchau** under Panchau Circle, Longding District.

The appointment is subject to the following terms and conditions :-

1. This appointment is made subject to approval of SPD, ISSE/Samagra Shiksha Itanagar, vide order No. AR/ISSE/ESTT/78/2019-20/6879-85, Dated Itanagar the 28<sup>th</sup> July'2020.
2. The contract Teacher has no right to claim for regular appointment/regularization of the post, after the expiry of contact engagement.
3. No Earned Leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.
4. If the incumbent remain absent, no pay will be paid for the absent period.
5. In case, the appointee is found not staying in his/her place of posting and not sincere in his/her duty, his/her contract service will be terminated at any time by the ISSE/Samagra Shiksha Society District Mission.
6. At the end of the contract agreement, the incumbent shall have to again enter into fresh contract for the next academic period.
7. During contract service period, He/She is not entitled for Medical Reimbursement, Winter Allowance, Children Educational Allowance, Reimbursement of Tuition Fees, Leave Travel Concession (LTC), Special ompensatory Allowances etc.
8. The appointed contract teacher have to join his/her duty at the posting place within 7 (Seven) days from the date of appointment, failing which his/her appointment order will automatically be treated as cancelled.
9. He/She is not entitled to subscribe GPF, NPS or CGEIS or such other schemes during the period of contract services.
10. No representation will be accepted for the change of posting place.
11. He/She will have to under go DIET Training at concern DIET Training Centre as when call for.
12. The appointed teacher has to sign an agreement for contract engagement before receiving this engagement order.
13. The other terms and conditions of service, which are not specified shall be governed by the relevant rules and order in forced time to time.
