- c) She/he will have to produce a Medical fitness certificate from an authorized medical officer to the effect that she/he is medically fit for the Government Service.
- d) The appointment is subject to the Police verification and he/she will be discharged from service with immediate effect if there be any adverse remarks against him/her in the Police report.
- e) He/she will be transferred to Schools any-where in Arunachal Pradesh.


The other terms and conditions of service which are not specified herein shall be governed by the relevant rules and order in force from time to time.
