ORDER

Contract Teacher Nakutan Marlong is hereby engaged as Contract Teacher on contract basis on the fixed pay of Rs. ₹ 207/- per day. With effect from the date of joining in the Govt. Primary Middle School Mengjeng Mori upto 31/03/2007 against the centrally sponsored scheme of SSA.

The engagement is subject to the following conditions.

- a) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract period.
- b) Annual leave is permissible except casual leave as per central civil service leave rule and as per terms and condition mentioned in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement, winter allowances, children educational allowance; reimbursement of tuition fees; leave travel concession (ETC); special compensatory allowances and any other such allowances.
- d) The contract teacher have to report his/her duty at posting place within 7(seven)days from the date of joining in the concerned DDSE's office failing which his/her engagement order will automatically be treated as cancelled.
- e) He/she is not entitled to subscribe GPF / CGEBIS or such other schemes during the period of contract services.
- f) The engaged teacher is also to work as volunteer instructor of TLC / PIP programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties. Further the engaged is also bound to perform any other duty assigned by the State Govt./ Dist. Administration/ Education Department in any addition to his/ her normal duties.
- g) No representation will be accepted for change of posting place.
- h) He/she will have to undergo DIET training at concerned DIET for training as and when called for.
- i) The other terms and conditions of services which are not specified shall be governed by the Relevant rules /Orders / Guide lines in force time to time.
- j) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
- k) His/Her contractual service will remain valid only upto 31.03.07 and thereafter it will be treated automatically terminated and a fresh renewal would be required.
- l) He/she will have to report for duty at his/her posting place positively on 01.04.06. His/her pay will be drawn only after getting joining report through the concerned APO(AE)/ADEO.
