**The engagement is subjected to the following conditions: -**

- A) The contract teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.
- B) No Earn Leave is permissible except leave as per CCS Leave rule and as per terms and condition mentioned in the agreement copy.
- C) During the contract service period he/ she is not entitled for Medical reimbursement; winter allowances; children educational allowances; reimbursement of tuition fees; leave travel concession (LTC); special compensatory allowances etc.
- D) The second party shall be entitling for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in Training, Bridge Course and any other departmental engagement.
- E) The contract teacher have to report his/ her duty at posting place within 7 (Seven) days from the date of joining in the office of the DDSE, failing which his/ her engagement order will automatically be treated as cancelled.
- F) He/ she is not entitled to subscribe GPF for CGEIS or such other scheme during the period of contract services.
- G) The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in additional to his/ her normal duties.
- H) No representation will be accepted for change of posting place.
- I) He/ she will have to under gone DIET training at concerned DIET for training as and when call for.
- J) The other terms and condition of services is are not specified shall be govern by religion rule and order in force time to time.
- K) The engage teacher has to sign an agreement for contract engagement before receiving this engagement order.
