ORDER

In pursuance of the administrative approval NO. SS-11030/3/2021 Dtd Itanagar the 21st November 2022, Shri, Tara Nirin is hereby engaged as Primary Teacher(PRT) on contractual basis at the Fix pay Rs. 15,000/- (Rupee fifteen thousand) only with effect from the date of joining in the school against Centrally Sponsored Scheme of Samagra Shiksha/ISSE. She is posted at Govt. Primary School, Phungsa

The appointment is subject to the following conditions: -

- 1) The contract service has no right to claim for regular appointment/regularization of the post after expiry of contract appointment.
- 2) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule as per terms and condition mentioned in the agreement copy.
- 3) During contract service period she/he is not entitle for medical reimbursement, winter allowance, children education allowance, reimbursement of tuition fees, leave travel concession(LTC), special compensatory allowance etc.
- 4) The contract service have to report his/her duty at posting place within 7(seven) days failing which his/her engagement order will be automatically be treated as cancelled.
- 5) She/he is not entitled to subscribe GPF or CGEIS or other schemes during the period of contract services.
- 6) No representation will be accepted for changing of posting.
- 7) The other terms and conditions of services which are not specified shall be governed by the relevant rules and orders in forced time to time.
- 8) She/he has to sign an agreement for contract before receiving this engagement order.
- 9) The contract service shall be terminated by the undersigned on receipt of substantive complaint from the concerned DDSE/DC of the district
