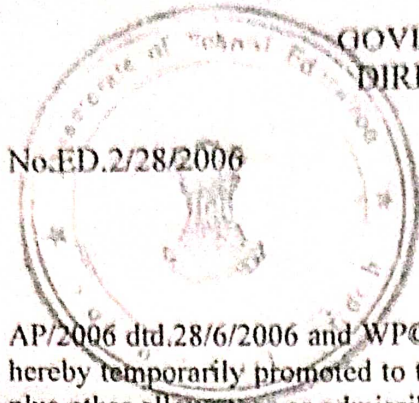

The promotion is made subject to the following conditions :-


- The promotion is purely temporary and liable to revert at any time without assigning any reasons thereof.
