

O R D E R

Shri Da Taysan is hereby appointed temporarily to officiate as Senior Teacher/Instructor in the Pay Band of Rs. 4300-24,800 - GP. Rs. 4200- per month and other allowances as admissible under rules in force with effect from the date he/she actually reports for duty to the Principal, Government Higher Secondary School, Kodak, Upper Subansiri District, Arunachal Pradesh.

The appointment is made against newly created post under order No. ED/2/573/APT/2009 dated 24.08.2009.

(A) The appointment is subject to the following conditions:-

- (i) The appointee shall be on probation for a period of 2 (two) years w.e.f. the date of joining. His/Her continuation in service beyond probation for 2 (two) years is subject to satisfactory performance during probation period.
- (ii) The appointment is purely temporary and may be terminated with 1 (one) month's notice if He/She wants to resign he/she may do so after giving 1 (one) month's notice or by surrendering 1 (one) month's salary.
- (iii) The regularization of service shall be considered on completion of probationary period subject to satisfactory performance of duty.
- (iv) After joining duty he/she will have to take an oath of allegiance of affirmation in the Constitution of India in the prescribed form.
- (v) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- (vi) The appointment is subject to the Police Verification and he/she will be dismissed from Government service if any adverse report is there with immediate effect.
- (vii) He/She shall remain in the place of posting minimum 3 (three) years from the date of joining. No representation/campaigning for the change of posting place shall be entertained before completion of minimum 3 (three) years of service.

Other terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
