- (f) On joining, the appointee shall have to serve for a minimum period of 3(three) years at the place of posting.
- (g) The seniority of the appointee shall be based strictly on merit list.
- (h) The appointment order shall be cancelled if the appointee directly or indirectly campaign for change of posting place or does not join within 10 (ten) days from the date of issue of this order at posting place.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules in force from time to time.
