The appointment is subject to the following conditions:-

2. He/She must report to the Principal DIET (BSB) Changlang on 16.6.88 positively. Last date of admission is 23.6.88, failing which order will stand cancelled.
3. NO TA/DA will be paid for attending training.
4. During the Training Period trainees will not be allowed any kind of leave except 12 days Casual Leave. In case of irregular attendance during the training the services may be terminated without assigning any reason.
5. Their further continuation in the post will be considered on successful completion of the training.
6. After joining he/she will have to take an oath of allegiance of give affirmation to the constitution of India duly in the prescribed form.
 - a) He/She will have to produce a Medical Certificate from an authorised Medical Officer to the effect that he/she is medically fit for Govt. service.
 - b) The appointment is subject to the Police Verification and he/she will be discharged from service with immediate effect if there be any adverse remarks against him/her in the police report.
7. The other terms and conditions which are not specified here would be governed by the rules and order that may inforce from time to time.
