## ORDER

Shri/Spati/Miss Nera Tana Tara is hereby engaged as J/F A/T (A) on contract basis in the fixed pay of Rs.7200/- (Rupees Seven thousand two hundred ) only with effect from the date of joining in the concerned district upto 31/3/2007 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan. He / She is posted at Primary/Upper Primary School, Yupia.

The engagement is made vice resignation/expire/waiting panel/not joined of Shri/Smti/Miss ,......JT/AT (Application in case of resultant vacancies).

The engagement is subject to the following conditions: -

a) The contract Teacher has no right to claim for regular appointment / regularization of the post after expiry of contract engagement.

b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per terms and conditions mentioned in the agreement copy.

- c) During contract service period he/she is not entitled for medical reimbursement; winter allowances; children educational reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowance etc.
- d) The contract teacher have to report his/her duty at posting place within 7 (Seven) days from the date of joining in the office of the concerned DPO failing which his/her engagement order will automatically be treated as cancelled.
- He/She is not entitled to subscribe GPF or CGIS or such other schemes during the period of contract services.
- The engaged teacher is also to work as volunteer instructor for TLC programme for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.

g) No representation will be accepted for change of posting place.

- He/She will have to undergo DIET training at concerned DIET for training as and when call for.
- The other terms and conditions of Service which are not specified shall be governed by the relevant rules and order in forced time to time.
- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.
