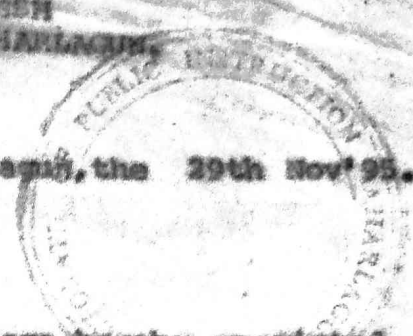

He/She will be transferred to schools any where in Arunachal Pradesh.


