ORDER

Sri Tony Tayeng is hereby engaged as AT (A) on contract basis in the field pay of Rs. 10,800 - p.m. (Rupees Ten thousand eight hundred only) with effect from the date of joining in the concerned district upto 2010-11 against Centrally Sponsored Scheme of Sarva Shiksha Abhiyan as reported in GPS, Bomi.

The engagement is subject to the following conditions:

- a) The contract teacher has no right to claim for regular appointment/regularization of the post after expiry of contract engagement.
- b) No earned leave is permissible except casual leave as per Central Civil Service Leave Rules and all other terms and conditions in the agreement copy.
- c) During contract service period he/she is not entitled for medical reimbursement, widow allowance, children educational allowance, reimbursement of tuition fees, leave travel concession of 1/3, Special compensatory allowances etc.
- d) The second party shall be entitled for drawal salary of only for the academic session. Salary for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
- e) The contract teacher have to report his/her duty at posting place within 7 (seven) days from the date of joining in the office of the concerned DDSE, failing which his/her engagement order will automatically be treated as cancelled.
- f) He/she is not entitled to subscribe GPF or CGEIS or such other schemes during the period of contract services.
- g) The engaged teacher is also to work as volunteer instructor for TLC programmed for the student of literacy in Attanachal Pradesh in addition to his/her normal duties.
- h) No representation will be accepted for change of posting place.
- i) He/she will have to under go DIET training at concern DIET for training as and when called.
- j) The other terms and condition of service which are not specified shall be governed by the rules, orders and order in force in force at the time.
- k) The engaged teacher has to sign an agreement for contract engagement before receiving the engagement order.
