Shri/ Smti/Miss Aming Liph is here engaged as 1/1/2016 onwards in the fixed pay of Rs.21,175/- (Rupees Twenty one thousand one hundred seventy five only) in the concerned district upto 2016-17 against centrally sponsored scheme posted at Primary/ Upper Primary School GPC, Arc Line Tuting.

The engagement is subjected to the following conditions:

- a) The contract teacher has no right to claim for regular doings mentioned in the contract engagement.
- b) No Earn Leave is permissible except casual leave as per Central Government condition mentioned in the agreement copy.
- c) During the contract-service period he/ she is not eligible for Medical allowances; educational allowances; reimbursement of tuition fees; leave travel allowances etc.
- d) The second party shall be entitling for drawl salary of only for the days he/ she is engaged shall be drawn only when they are engaged in Training, Bridge Course and orientation.
- e) The contract teacher have to report his/ her duty at posting place within 15 days from the date of joining in the office of the concerned ODSE, failing which his/ her engagement order will automatically be treated as cancelled.
- f) He /she is not entitle to subscribe GPF for CGEIS or such other scheme during the course of contract services.
- g) The engaged teacher is also to work as volunteer instructor for the promotion of interest of literacy in Arunachal Pradesh in addition to his/ her normal duties.
- h) No representation will be accepted for change of posting place.
- i) He/ she will have to undergone DIET Training at concerned DIET for the concerned post.
- j) The other terms and condition of services which are not specified in the agreement may be changed in forced time to time.
- k) The engaged teacher has to sign an Agreement for contract engagement.
