- The contract teacher has no right to claim for regular appointment/ regularization of the post after expiry a) of contract engagement.
- No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and as per b) terms and conditioned in the agreement copy.
- During contract service period he/ she is not entitle for medical reimbursement; winter allowance; c) children educational allowance; reimbursement of tuition fees; leave travel concession (LTC); Special compensatory allowances etc.
- The second party shall be entitling for drawal salary of only for the academic session. Salaries for vacation d) period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
