ORDER

Set Kuro Tales is hereby engaged as AT(A) on contract basis at the fixed pay of Rs. 10,800/- p.m. (Rupees Ten thousand eight hundred only) with effect from the date of joining in the concerned district upto 2010-11 against a morally Sponsored Scholastic of Sarva Shiksha Abhiyan which is posted in Gost Log School Puzzing.

- (a) The contract tea-her has no right to claim for regular appointment/ regularization of the post after expiry of contract engagement.
- (b) No Earned leave is permissible except casual leave as per Central Civil Service Leave Rule and in per terms and conditioned in the agreement copy.
- (c) During contract service person be engaged not entitle for medical expenses, children educational allowance, reimbursement of tuition fees, leave travel allowances, Special compensatory allowances etc.
- (d) The second party shall be entitled for drawal salary of only for the academic session. Salaries for vacation period shall be drawn only when they are engaged in training, Bridge course and any other departmental engagement.
- (e) The contract teacher have to report his/her duty at posting place within 7 (seven) days from date of joining in the office of the concerned DPO, failing which his/her engagement will automatically be treated as cancelled.
- (f) He/she is not entitle to subscribe GPF or CGFIS or such other schemes during the period of contract services.
- (g) The engaged teacher is also to work as volunteer instructor for TLC programmed for the interest of literacy in Arunachal Pradesh in addition to his/her normal duties.
- (h) No representation will be accepted for change of posting place.
- (i) He/she will have to undergo DIET training at concern DIET for training as and when will.
- (j) The other terms and conditions of service which are not specified shall be governed by the rules and order in forced time to time.
- (k) The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.


