- (b) After joining duty he/she will have to take an oath of allegiance of give affirmation to the constitution of India duly in the prescribed form.
- (c) She/He will have to produce a Medical certificate from an authorised medical officer to the effect that she/he is medically fit for the Government service.

3. The appointment is subject to the Police verification and he/she will be discharged from service with immediate effect if there be any adverse remarks against him/her in the police report.
