**ORDER**

In pursuance of Govt. approval vide U.O. No. Dated 03/03/2008 the service of Shri/Smti/Miss Tamong Palon is hereby regularized temporarily to officiate as Assistant Teacher(A) in the Scale of Pay of Rs.4500-125-7000 p.m. plus other allowances as admissible under Rules from time-to-time w.e.f. he/she actually reports for duty to the DDSE, Aalo, West Siang District, Arunachal Pradesh. He/She is posted under disposal of DDSE, Aalo.He/She is appointed against Shri/Smti Tage Nabum, AT(A) promoted to JT.

- b) The continuation of service will be subject to satisfactory performance of duty during probation period.
- c) After joining He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police Verification and He/She will be dismissed from Govt. service if any adverse report is there with immediate effect

The terms and conditions of service which are not specified herein shall be governed by the relevant Rules & Orders in force from time-to-time.
