ORDER

In pursuance of Govt. approval vide U.O. No. dated 27/3/06 the service of Chow Shirijie Namchoom is hereby regularized temporarily to officiate as Asst. Teacher (A) in the scale of pay of Rs. 4500-125-7000/- p.m. plus other allowances as admissible under rules from time to time with effect from he actually reports for duty to the DDSE, Tezu, Lohit District, Arunachal Pradesh. He is posted under disposal of DDSE, Tezu.

The appointee shall be on probation for a period of 2 (two) year w.e.f. the date of joining. His continuation in service beyond probation periods for 2 (two) years is subject to satisfactory performance during probation period.

The appointment is subject to the following conditions -

- a) The appointment is purely temporary and will be terminated with 1 (one) month notice. If he wants to resign he may do so after giving 1 (one) month notice or by surrendering 1 (one) month salary.
- b) The continuation of service will be subject to satisfactory performance of duty during probation period.
- c) After joining he will have to produce Medical Fitness certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police Verification and he will be dismissed from Govt. service if any adverse report is there with immediate effect.
