- The order terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.



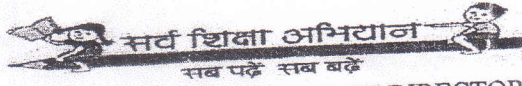

- He / she will have to under gone DIET training at concern DIET for Training as and when call for.

- The engaged teacher has to sign an agreement for contract engagement before receiving this engagement order.


