ORDER

In pursuance of Govt. approval vide U.O.No.400 dtd.16/10/07, the services of Ms. Yayong Taggu working an Educational Worker is hereby promoted & appointed on temporarily to the post of Assistant Teacher in the scale pay of Rs.4500-125-7000/- p.m. plus other allowances as admissible under rules from time to time with effect from the date he/she actually reports for duty to the DDSE, Aalo, West Siang District, Arunachal Pradesh.

The promotion is made against Late Tajo Taggu, AT(A) expired.

The appointment is subject to the following conditions :-

- (a) The promotion & appointment is purely temporary and may be terminated at any time by giving 1(one) month notice.
- (b) After joining duty he/she will have to take an oath of allegiance of affirmation to Constitution of India in the prescribed form.
- (c) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- (d) The promotion & appointment is subject to the Police Verification and he/she will be dismissed from Govt. service if there is any adverse report against him/her.
- (e) On joining, the appointee shall have to serve for a minimum of 2 (two) years at the place of posting.
- (f) The appointment order shall be cancelled, if the appointee directly or in-directly campaign for change of posting or does not join within 10 (ten) days from the date of issue of this order.

Other terms and conditions of service, which are not specified herein, shall be governed by the relevant rules and order in force from time to time.
