2. The appointment shall be on probation for a period of 2 (two) years w.e.f. the date of joining. His / her continuation beyond probation period for 2 (two) year shall be subjected to satisfactorily performance during probation period.

The Appointment is subjected to the following conditions:-

- 1. The appointment is purely temporary and may be terminated at any time by giving 1 (one) month notice. If he/she wants to resign, he / she may do so after giving one month notice or by surrendering one month salary.
- 2. The confirmation of service will be considered on completion of probationary period subjected to satisfactory performance of duty.
- 3. After joining duty he / she will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- 4. The appointment is subjected to Police Verification and he / she will be dismissed from service if any adverse report is found against him/her with immediate effect.
