2) The Officer shall be on probation for a
period of 2(two) years with effect from the date of joining. His/
her continuation in service beyond probation period of two years
is subject to satisfactory performance during probation period.

3) The appointment is subject to the
following conditions :-

- a) The appointment is purely temporary and may be terminated at
any time without assigning any reasons after serving one month
notice. If he/she wants to resign may require to give one
month salary.
- b) After joining in the duty he/she shall have to take an oath
of alligiance of affirmation to the Constitution of India in
the prescribed form.
- c) He/She will have to produce medical fitness certificate in
prescribed form from an authorised medical officer.
- d) The appointment is subject to Police verification and he/she
will be dismissed from Govt. service if any adverse reports
are there with immediate effect.


