ORDER.

In pursuance of Govt. approval vide UO No. 513 dated 06/12/10, Shri Brahmanand Mishra, CL XII (Sc) passed is hereby appointed temporarily to the post of Laboratory Assistant on compassionate ground in pay band of Rs. 9300-34800+4200/- p.m plus other allowances as admissible under the Rules from time to time with effect from the date he actually reports for duty at Govt. Higher Secondary School, Kaying, under DDSE, Aalo, West Siang District.

The appointment is made on compassionate ground as per the Govt. of India Ministry of Home Affairs order No. 1404 P.O. (I) (D) dated 09/12/93. The appointment is made against the vacancy of Miss. Kanchan Nani (Laboratory Assistant) resigned.

The appointment is made subject to the following conditions:-

- a) The appointment is on probation for a period of 3(three) years. During probationary period, his/her services may be terminated at any time without any notice or assigning any reason. The regularization of service will be considered on completion of probationary period subject to satisfactory performance of duty.
- b) After joining duty, he/she will have to take on Oath of allegiance of affirmation to the constitution of India in prescribed form.
- c) He/ She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- d) The appointment is subject to the Police verification and he will be dismissed from service, if any adverse report is there with immediate effect.
- e) On his appointment as Lab. Assistant he should produce B.Sc. Certificate within 3 (Three) years failing which their appointment shall be cancelled.

The other terms and conditions of service which are not specified herein shall be governed by the relevant rules and orders in force from time to time.
