ORDER

- c) The regularization of service shall be considered on completion of probationary period subject to satisfactory performance of duty in his/her initial place of posting.
- d) After joining duty, he/she will have to take an oath of allegiance of affirmation to the Constitution of India in the prescribed form.
- e) He/She will have to produce Medical Fitness Certificate from an authorized Medical Officer.
- f) The appointment is Subject to the Police Verification and he/she will dismiss from government service if any adverse report is there with immediate effect.

The other terms and conditions which are not specified herein would be governed by the rules and order that may inforce from time to time.
